

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The Courts in Beaverton and Oregon Juniors Volleyball Academy (“the Facility”) has put in place preventative measures to reduce the spread of COVID-19; however, the Facility cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the Facility could increase your risk and your child(ren)’s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the Facility and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Facility may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Facility employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)’s attendance at the Facility or participation in Facility programming (“Claims”). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Facility, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Facility, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Facility program.

Preventative Action that the Facility is taking and that the participant must adhere to:

- 1) If you have family that you are in contact with that work in the CoVid 19 health care industry you are asked not to attend without having a 14-day quarantine.
- 2) Anyone that is in a home or has attended a location that has had a positive test for CoVid 19 should not be coming to the facility
- 3) Facility will have a monitor to insure that these guidelines are followed.
- 4) Beginning July 24th, face coverings are required in all public indoor facilities. We will require all athletes & coaches to wear a mask while entering and exiting the building. **Athletes and Coaches are required to wear a mask while training.**
- 5) Must use Approved CDC hand sanitization wipes before and after each session.
- 6) All balls and equipment will also be wiped down after each session with CDC Approved wipes
- 7) There is CDC approved space between active courts. Max of 12 players on 4,000 sf court
- 8) Players will not be able to congregate, socialize in groups. Social distancing will take place for all drills.
- 9) Players will be admitted through one door and released thru another so there will be no passing of players
- 10) Sessions will be started at staggered times, with buffer times between sessions
- 11) Players must go straight to the court assigned
- 12) No parents or fans will be allowed in the facility.
- 13) Players will have limited use of the restrooms and must wipe down the area they have touched with approved wipes and wash hands for the recommended amount of time.
- 14) Players and coaches will be temperature checked as they enter the facility.
- 15) Players and coaches must come dressed in playing cloths and **cannot** bring any bags, backpacks into facility
- 16) Players and coaches must bring all of their own hydration fluids. These must not be shared with anyone.
